

Hon. Justice Kenneth Kakuru the founding partner of Kakuru & Co. Advocates passed away early this year on 7th March 2023. The late Hon. Litigation

Kakuru & Co. Advocates (Kadvoc) has obtained victory in all litigation matters whose judgment was delivered this year. Most notably, a landmark decision in the Supreme Court regarding an extremely contentious land matter in the case of Steven Kalanzi Katabazi, Henry Senoga, Isaac Matovu Versus Ignatius Kadoma and Hati Kobusingye Civil Appeal No. 3 of 2018. Facts being that the respondents (our clients) sued the appellants for trespass on 0.18 acres in their property comprised in Kyadondo Block 269 Plot 25, land at Lubowa, where upon the appellants counter claimed against the respondent for a declaration that they had a right of use of the 0.18 acres as an access road to their Plot and that the respondent was guilty of a private nuisance against the appellants for erecting a wall on the access road. The High Court allowed the suit of the respondents, dismissed the counterclaim of the appellants and issued orders as to damages and made declarations against the

appellants. Being dissatisfied, the appellants appealed to the Court of Appeal which dismissed the appeal but reduced on amount of damages ordered by the High Court, the appellants filed a second appeal to Supreme Court which was equally dismissed the suit with costs to the respondents (our client). Additionally, we have advised a number of our clients and settled most of their

matters outside court hence avoided unnecessarily litigation. In similar regard, we have commenced litigation in instances where our team has

assessed and found it to be the most suitable means to achieve our clients' remedies/protect their interests.


